## **Snooker & Pool Club Membership Rules**

### January 2012

The Centre of Pendeen promotes a friendly environment in which members can enjoy snooker and pool.

- 1. Membership is open to all persons over the age of 16 (sixteen), at the discretion of the Committee.
- 2. A member (21 or over) who wishes an under sixteen person to play snooker or pool must have that person as a named junior on their membership form/record. A small fee is charged for juniors.
- 3. Non members and persons under the age of sixteen must be accompanied by a member (21 or over) at all times whilst on the premises. Key fobs are not issued to non members and under 16s.
- 4. Members must not use their key fob to regularly admit non members or anyone not named on their membership form/record
- 5. All members, guests and under 16s must sign the register in the snooker room before play commences.
- 6. Members may only sign in the same guest 3 three times in any 12 month period. (Regular guests must be encouraged to join the club)
- 7. Upon joining the club, new members will receive a key fob which allows access to the building during opening times. Key fobs cost £10.00 each (Refundable upon termination of membership and on return of the fob) but remain the property of the Centre.
- 8. Members who lose their key fob must report the loss immediately to Centre staff or a member of the committee who will arrange for that fob to be deactivated. Replacement key fobs cost £10.00
- 9. Key fobs will stop working at the time of membership renewal and reactivated upon payment of full annual subscription.
- 10. Membership entitles the use of all facilities every day at the published times, which are subject to change.
- 11. Facilities may not always be available because of pre-arranged matches, functions or activities.
- 12. Under sixteen's cannot place their names on the board to play snooker but can take the place of a member in a game if the other players agree.
- 13. Under sixteen's will have a designated time to play snooker/pool providing 2 members over 21 are available to supervise.
- 14. Any member of staff or committee member, can at any time ask a non-member or member who is not obeying the rules to leave the premises. Anyone asked to leave the premises may appeal in person or writing at the next committee meeting.

# Members are additionally required to:

- · Respect the building and equipment.
- · Be respectful of all other users of the building.

- Use the village car park and not park on the road outside the building.
- Leave the building in a clean and tidy condition and ensure any rubbish is put in the bins provided. The
  Centre of Pendeen is committed to recycling so please use the recycling bins provided wherever
  possible.
- Report any breakages to the Centre volunteers or a member of the committee. Breakages must be paid for at the current market value.
- Ensure that the door is firmly closed on leaving the building.

Leave the building in a quiet manner so as not to disturb the immediate neighbours.

### Members must not:

- Smoke on the premise. Smoking in a public building is now illegal.
- Bring alcohol or food onto the premises without authorisation from the committee.
- · Bring drugs onto the premises or be under the influence of drugs or alcohol whilst in the building.
- Use or remove items not belonging to them without the owners consent.
- Use their swipe card to regularly admit non members onto the premises. The breaking of this rule will result in an instant ban. (see rule 4)

If you are aware of anyone who is not observing the membership rules, you must inform a Centre volunteer or a member of the committee.

Any member who is considered to have breached the rules will have their membership withdrawn.
